

The Glenburn and Lansford parish meeting was held April 13, 2011 at 8 P.M. in Lansford . Those present included: Jan Hartle, Dustin Undlin, Greg Morlock, Peggy Undlin Judy Routledge, Pastor Heather, Brian Christianson, Mickey Mickelson, and Michelle Schumann.

Pastor Heather called the meeting to order and had the opening devotions and prayer. Pastor stated we need to elect a new parish president this year from Lansford.

Dustin moved we nominate Greg Morlock for the president position. Seconded by Michelle. Greg was agreeable to be president. Brian then moved we accept Greg for the president position, seconded by Jan. Motion was then carried.

The secretary's minutes were read. Jan moved and Mickey seconded that the minutes be approved. Motion was carried.

Pastor stated that two computers and a new printer were donated to the church. She also said that the church now has wireless DSL. Pastor also said that she now has a new cell phone service which is less expensive.

The treasurer's report was not available but Pastor stated that we have over \$6000 in the account.

Jan moved and Brian seconded that we cast a unanimous ballot for Michelle as the parish secretary. Motion was carried.

Dustin moved and Michelle seconded that we discontinue our membership with the Camp of the Cross, since we already support Camp Metigoshe. Motion was carried.

Discussed was the present \$500 limit on council spending (as stated in the constitution) . As it is now, anything over \$500 has to be brought up 3 times to the congregations then voted on it. It was suggested due to the increase in costs of everything that maybe the limit be increased. It was decided that we would table this until the Oct. meeting. We also need to look at the constitution to clarify it.

Pastor stated a Mike Ewaldson from Kansas speaks to churches and provides music. It is called "Dunamos Ministries." All were in favor of this. Jan moved and Mickey seconded that Lansford and Glenburn Lutheran each pay \$200 and Lansford Methodist pay \$100. Toward this presentation plus have free will offerings at each of the churches. Motion was carried.

Pastor suggested we have a new Parish directory made possibly in the fall. There would be no cost to the church. Brian moved and Dustin seconded that we proceed with this. Motion carried. Pastor will check available dates..

Pastor will be gone June 12 to 24th. She is lining up speakers for the Sundays she is gone.

The Parish picnic will be Aug. 7th at in Glenburn. Worship at 11 with the picnic after. The parish provides hot dogs and plates. Greg volunteered to help Glenburn with planning.

Greg stated they are waiting to see if the Lansford Lutheran church could be turned into apartment or not.

The Methodist annual conference will be in June. The relationship with the Lansford Lutheran church will be voted on then.

Brian moved and Jan seconded that we approve pastor's request for May 29th off. Motion carried.

Brian moved and Dustin seconded that the meeting be adjourned. Motion carried. All said the Lords Prayer.
